Important Notice to MPF University Users

Due to changes coming to MPF University, the current website will not be available after February 12, 2018.

If you are a registered user of MPF University and have courses in progress or required courses to complete, they must be completed by February 12, 2018. After that date, access to MPF University courses and user transcripts will no longer be available.

Watch for an upcoming announcement about our new MPF University site which will be launched in the very near future!

In the meantime, we strongly encourage users to obtain a copy of their transcripts to retain for their records. Transcript copies will not be available after February 12. To access courses, transcripts, and certificates, you must login to the MPF University (Ellie Learns) website before February 12. There is a link for transcripts on the homepage.

Please note that the login process was updated in October of 2017. If you have not accessed your account since October 2017, you must establish a new user ID,

password and security question (see the attached document, MPF University Access for Pre-October 2017 Users for instructions). Additionally, Encompass users should now access MPF University courses by using their standard protocol from the Ellie Mae Resource Center (see the attached document, MPF University Access for Encompass Users for instructions). MPF University Access for Pre-October 2017 Users

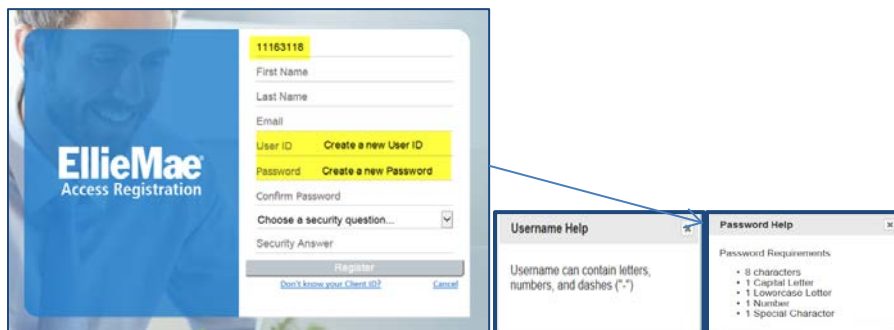
If your last login was before October 1, 2017 and you are *not* an Encompass user, follow these steps to create new credentials:

Access the MPF University login page by visiting the MPF website: www.fhlbmpf.com

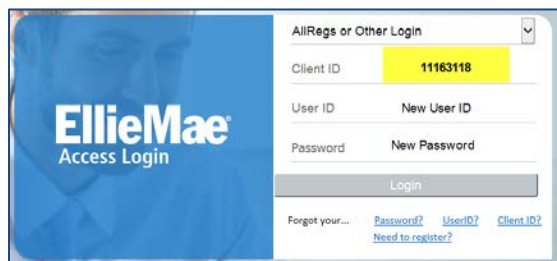
Click on the *EDUCATION* link and drop down to *MPF University*. Under the *Already a Member* section, click on *Go To Access*



On the Access Registration screen, **Make note of the Client ID.** Complete the Name and Email fields. **Create a NEW User ID and Password.** Rules for user IDs and passwords are provided by clicking to the right of the applicable field. Make note of your new User ID and Password. Complete the Security Question and Answer.



Click **Register**. It should confirm that registration was successful. Click on the link to access the login screen. Enter your Client ID (**11163118**) along with your new User ID and password. After clicking Login, you will see a link to confirm your email and access to the site.



Click here to verify your email to access your applications.



Click on the icon and check for an email which will contain an access link (be sure to check your spam folder if it does not arrive immediately). After clicking on the access link in the email, you may login to your account.

Accessing Ellie Learns Learning Portal from Encompass

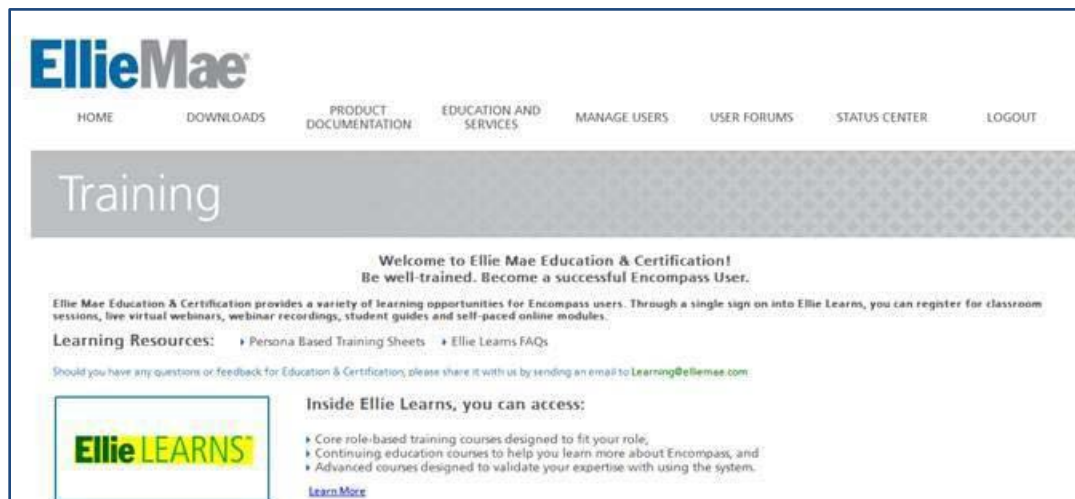
As an existing Encompass user can access the learning portal (EllieLearns) via the **EDUCATION SERVICES** tab on the Ellie Mae Resource Center. It is within EllieLearns where all training products for your company's active training subscriptions as well as the MPF University content reside. Any existing Ellie Learns users that do not have or will not be provided access to Encompass should follow the log on instructions under "Accessing Ellie Learns Learning Portal for Non-Encompass Users".

Accessing Your Training From Encompass

1. From Encompass **HOME** page, click "**Go to Resource Center**" link within second block on the right-hand side of the screen.
2. Click on the "Education Services" tab in the Resource Center.



3. Click on the "Ellie Learns" image on the Education and Services page.



- 4. Through the single sign-on process, you will automatically be logged in to the Ellie Mae's learning portal, landing on your My Learning page. Here any pre-assigned coursework will be visible.
