#### <u>MPF Announcement 2023-84:</u> MPF Xtra Servicing Updates – FNMA SVC-2023-05

Fannie Mae updated the Loan Modification Agreement, minimum requirements for law firms selected and retained for default-related legal services, incorporated updates from LL-2023-04, and added guidance for reapplying principal payments, all of which are applicable to mortgages serviced under the MPF Xtra product.

#### <u>MPF Announcement 2023-85:</u> MPF Traditional & MPF Xtra – Request for Release of Documents Reminder

In efforts to ensure document release requests are submitted in a timely manner, the MPF Program will be distributing a monthly report notifying PFIs of mortgage loans that have been liquidated but have collateral files that have not been requested for release form the MPF Program Custodian.
