# **Instructions Page**

### Purpose

Servicers of MPF Government MBS loans must use this form to request the release of documents held by the MPF Government MBS Custodian in accordance with MPF Government MBS Servicing Guide Chapter 1.

### Preparation

- When: The Servicer must complete this form when requesting the release of documents held by the MPF Government MBS Custodian.
- Who: This form must be completed by an employee of the Servicer who is specifically designated on the most recent Delegation of Authority Requests for Files from Custodian.
- **How:** If the reason for requesting the release of documents falls into the "other" category, the Servicer must input one of the following reason codes:

## Submission

- When:
  - Payoff/Liquidation the Servicer must submit the form as soon as possible upon payoff/liquidation. To avoid penalties all requests must be submitted to the custodian no later than the second business day of the month following payoff/liquidation (i.e. Request for Release of Documents for all January payoffs must be submitted by the 2nd business day of February).
  - Any other reason documents are needed the Servicer must submit this form when requesting the release of documents held by the MPF Government MBS Custodian, allowing 3-5 Business Days for processing.
- How:
  - If completing this form in conjunction with Form SG350-M (Uninsurable Government MBS Mortgage Loan Notification), please email the completed form to <u>mpf\_custody@fhlbc.com</u>.
  - If completing this form for any other reason, the Servicer must email the completed form to <u>SantaAna.CustodyRequests@db.com</u>.
- To Whom:
  - If completing this form in conjunction with Form SG350-M (Uninsurable Government MBS Mortgage Loan Notification), please submit the completed form to the MPF Provider Loan Accounting Department per the instructions on Form SG350-M.
  - If completing this form for any other reason, the Servicer must submit the completed form to the MPF Government MBS Custodian.

### The Servicer should retain a copy of the completed form for their own records.

#### **Helpful Hints**

- The MPF loan number must be provided for all requests.
- The MPF Government MBS Custodian will only release documents to the person and address specifically designated on the most recent Delegation of Authority Requests for Files from Custodian.
- Documents are not permitted to be released to subservicers.
- Release request processing time:
  - MPF Government MBS: 3-5 Business Days
- For MPF Traditional loans submit SG340 and for MPF Xtra loans submit SG340-X
- Notes will be returned to PFI by UPS or FedEx, and cannot be returned by USPS.
